**"A RESOLUTION ADOPTING MUNICIPAL PEACE AND ORDER COUNCIL RESOLUTION NO. 2019-01 TO TRANSFER FUNDS FROM THE APPROPRIATION FOR THE CONDUCT OF MONTHLY/QUARTERLY MEETING ON MPOC/MADAC; CONDUCT OF SKILLS TRAINING ON LIVELIHOOD FOR DRUG SURRENDERIES AND ADVOCACY/IEC ON RA 8550 & RA 10654 TO THE APPROPRIATION FOR ORGANIZED BARANGAY TANOD/BANTAY DAGAT/BINS; ALLOWANCES AND HONORARIUM FOR PEACE AND ORDER AND PUBLIC SAFETY OF THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR."**

WHEREAS, the Municipal Peace and Order Council (POC) during their meeting has agreed to transfer funds from the appropriation for the Conduct of monthly/quarterly meeting on MPOC/MADAC amounting One Hundred Twenty Thousand Pesos (P120,000.00); Conduct of skills training on livelihood for drug surrenderies amounting One Hundred Thousand Pesos (P100,000.00) and advocacy/IEC on RA 8550 & RA 10654 to fisherfolks amounting Fifty Thousand Pesos (50,000.00), a total of Two Hundred Seventy Thousand Pesos (P270,000.00);

WHEREAS, the total amount of Two Hundred Seventy Thousand Pesos (P270,000.00), shall be transferred to the appropriation for Barangay Tanod/Bantay Dagat/BINS, and Honorarium/Allowances for Peace and Order and Public Safety of San Pablo, Zamboanga del Sur.

WHEREFORE, on motion by Hon. Bienvenido E. Quirante, duly seconded by Hon. Artemio C. Dayondon, be it

RESOLVED, as it is hereby resolved, adopting Resolution no. 2019-01 of the Municipal Peace and Order Council of San Pablo, Zamboanga del Sur.
