EXCERPT FROM THE MINUTES OF THE 8<sup>TH</sup> REGULAR SESSION OF THE 10<sup>TH</sup> MUNICIPAL COUNCIL (Under the Local Government Code of 1991) HELD AT THE OFFICE OF THE MUNICIPAL VICE MAYOR, SAN PABLO, ZAMBOANGA DEL SUR ON MARCH 18, 2020.

**RESOLUTION NO. 20200313**

**"A RESOLUTION AUTHORIZING HONORABLE MAYOR DANILO A. TAUCAN TO SIGN/EXECUTE A DEED OF DONATION IN FAVOR OF THE SUPREME COURT (LOT SITE FOR HALL OF JUSTICE BUILDING)."**

**WHEREAS**, per Memorandum of Agreement (MOA) dated January 15, 2019, signed and entered into by and among the Local Government Units (LGUs) of DUMALINAO, TIGBAO, GUIPOS and SAN PABLO, ZAMBOANGA DEL SUR, this municipality had jointly agreed to purchase with them, as they had in fact already purchased a lot as site as agreed, to be donated to the Supreme Court for it to construct a Hall of Justice Building thereon which will hopefully house the office of the 8<sup>TH</sup> Municipal Trial Court (8<sup>th</sup> MCTCA) of Dumalinao-Tigbao-Guipos-San Pablo, all of Zamboanga del Sur (ZDS);

**WHEREAS**, the Hall of Justice Building, apart from serving as an added landmark structure for the 4 LGU's, will also ultimately benefit the people served by the 8<sup>th</sup> MCTC Dumalinao, et al.,

**WHEREAS**, to facilitate the execution of the deed of donation papers as above cited, it is practical and expedient that LGU's Chief Executive, Hon. Danilo A. Taucan, be given full authority to sign and execute the Deed of Donation in favor of the Supreme Court, together with all pertinent documents related therewith, in behalf of, and for and in the name of this municipality.

**WHEREFORE**, on motion by Hon. Allan S. Ceño, severally seconded, be it

**RESOLVED**, as it is hereby resolved, **authorizing Honorable Mayor, Danilo A. Taucan, to sign/execute a deed of donation in favor of the Supreme Court (Lot site for Hall of Justice Building).**
