RESOLUTION NO. 20200416

"A RESOLUTION AUTHORIZING HONORABLE MAYOR DANILO A. TAUCAN AND THE OIC MUNICIPAL TREASURER, MRS. DIONA W. WAMILDA OF THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR, TO OPEN A SPECIAL ACCOUNT AT LAND BANK OF THE PHILIPPINES (LBP) FOR THE BAYANIHAN GRANT TO CITIES AND MUNICIPALITIES (BGCN)."

WHEREAS, the Department of Budget and Management (DBM) issued LBC No. 125, dated April 7, 2020; guidelines in the release and utilization of the Bayanihan Grant to Cities and Municipalities, citing Sec. 4 of RA 11469 (Bayanihan to Heal as One Act) as legal basis;

WHEREAS; under the guidelines of LBC 125, the grant shall be equivalent to the one-month FY 2020 Internal Revenue Allotment share of the cities and municipalities;

WHEREAS, the said Bayanihan Grant to Cities and Municipalities (BGCN) shall be exclusively used by the cities and municipalities for the COVID-19- related programs, projects, and activities (PPAs) and expenses as enumerated under 3.5.1 to 3.5.12 of Local Budget Circular (LBC) no. 25 .

WHEREFORE, on motion by Hon. Erlinda P. Castillo, severally seconded, be it

RESOLVED, as it is hereby resolved, authorizing the Municipal Mayor Hon. Danilo A. Taucan and the OIC Municipal Treasurer, Mrs. Diona W. Wamilda of San Pablo, Zamboanga del Sur to open a special account at Land Bank of the Philippines (LBP) for the Bayanihan Grant to Cities and Municipalities (BGCN).
