EXCERPT FROM THE MINUTES OF THE 19TH REGULAR SESSION OF THE 10TH MUNICIPAL COUNCIL (Under the Local Government Code of 1991) HELD AT THE OFFICE OF THE MUNICIPAL VICE MAYOR, SAN PABLO, ZAMBOANGA DEL SUR ON JULY 22, 2020.

RESOLUTION NO. 20200729

"A RESOLUTION TRANSFERRING ITEMS FROM THE GENDER AND DEVELOPMENT (GAD) PLAN AND PROGRAM AMOUNTING TWO MILLION TWO HUNDRED EIGHTY THOUSAND PESOS FOR THE CONSTRUCTION OF COVID CENTER AND OTHER COVID-RELATED EXPENSES."

WHEREAS, in line with the code alert system for COVID 19, 2020 which was raised to Code Alert Sublevel 2 on March 12, 2020 by the Inter-Agency Task Force for the Management of Emerging Infectious Disease, there is an urgent need to safeguard the Local Populace of San Pablo, Zamboanga del Sur against the threats of COVID 19;

WHEREAS, to prevent further transmission of the said virus, the Body agreed to appropriate funds to construct COVID 19 Isolation facility and other related expenses.

WHEREAS, the following items from the GAD budget for 2020 are hereby transferred for the following:

1. Construction of Men and Women Ligtas Covid Center	P 800,300.00
2. Procurement of Rapid Testing Kits	681,250.00
3. Rice Assistance for Persons under monitoring	437,500.00
4. Provision of Water System at SPCEs Isolation Facility	75,000.00
5. Meals and Snacks for Security Personnel's manning COVID 19 check points	<u>285,950.00</u>






