**"A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. DANILO A. TAUCAN TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT THROUGH THE BUREAU OF LOCAL GOVERNMENT DEVELOPMENT (BLGD) FOR THE CONDUCT OF COMMUNITY BASED MONITORING SYSTEM (CBMS) IN THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR."**

**WHEREAS**, Community-Based Monitoring System (CBMS) is a tool developed to provide policy makers a systematic gathering of data intended for improved governance and greater transparency and accountability in resource allocation that will track impacts of various economic reforms and policy.

**WHEREAS**, the municipal officials of LGU San Pablo, ZDS, has approved an amount for the conduct of Community Based Monitoring System (CBMS) Module 1 in the Municipality of San Pablo, Zamboanga del Sur;

**WHEREAS**, the CBMS Network Team currently based at the DLSU Angelo King Institute for Economic and Business Studies (DLSU-AKI), provides technical assistance to National and Local Government Units in the Philippines on the development and institutionalization of CBMS and its use for planning, program formulation and impact monitoring.

**WHEREFORE**, on motion by Hon. Erlinda P. Castillo, duly seconded by Hon. Artemio C. Dayondon, be it

**RESOLVED**, as it is hereby resolved, authorizing the Municipal Mayor, Hon. Danilo A. Taucan to enter into Memorandum of Agreement (MOA) with the Department of Interior and Local Government through the Bureau of Local Government Development (BLGD) for the conduct of Community-Based Monitoring System (CBMS) in the Municipality of San Pablo, Zamboanga del Sur.
