"A RESOLUTION REQUESTING THE HONORABLE SANGGUNIANG PANLALAWIGAN
MEMBERS TO INCLUDE THE SAN PABLO PUBLIC TRANSPORT ROUTE PLAN IN THE INTRA –
MUNICIPALITY ROUTE PLAN OF THE PROVINCE OF ZAMBOANGA DEL SUR."

WHEREAS, the San Pablo – Local Public Transport Route Plan (SP-LPTRP) thru its Committee Chairman, Hon. Mayor Danilo A. Taucan is requesting this August Body to approve their proposed SP-LPTRP as follows:

- San Pablo Pagadian Route
   -With existing 20 PUV units, 3 Buses and 5 PUJ's operating daily
- Baganian Area San Pablo Pagadian Route
   -Thru Secondary National Road (Coastal Road)
