**"A RESOLUTION SIGNIFYING THE INTENTION OF THE MUNICIPAL OFFICIALS OF SAN PABLO, ZAMBOANGA DEL SUR TO AVAIL OF THE TREATED BULK WATER SUPPLY PROJECT OF GLORIOUS ENVIRONMENTAL SOLUTIONS TECHNOLOGIES, INCORPORATED."**

**WHEREAS**, not all Barangays in the entire Municipality of San Pablo has water connections in their respective household, some are still getting their supply for kitchen use in deep wells especially in mountainous areas like Bag-ong Misamis, Songgoy and other remote areas of the town;

**WHEREAS**, water connections in the heart of the Town are oftentimes interrupted by floods that destroy the pipe lines near the water source during rainy season, if not, insufficient supply during dry season;

**WHEREAS**, it is always a dream of the people in the nearby barangays to be given sufficient supply of potable water and even enough water for kitchen and other household use;

**WHEREAS**, the municipal officials believes that availing of the project of Glorious Environmental Solutions Technologies, Inc., benefits majority of the Barangay people of the entire town.

**WHEREFORE**, on motion by Hon. Allan S. Ceño, severally seconded, be it
