**RESOLUTION NO. 20201051**

**"A RESOLUTION REQUESTING DANGEROUS DRUGS BOARD CHAIRMAN CATALINO CUY TO ALLOCATE THE AMOUNT OF THREE MILLION FOUR HUNDRED THOUSAND PESOS (P3,400,000.00) FOR THE PROPOSED CONSTRUCTION OF MULTI-PURPOSE BUILDING/LOCAL DRUG EDUCATION CENTER AT BARANGAY TENIAPAN, SAN PABLO, ZAMBOANGA DEL SUR."**

**WHEREAS**, the Municipal Officials of San Pablo, Zamboanga del Sur has made very significant gains in its campaign against drugs through holistic, community-based approach that empowers ordinary residents to take an active part in the on-going crusade towards a drug-free municipality;
