**RESOLUTION NO. 20201273**

**"A RESOLUTION AUTHORIZING HON. DANILO A. TAUCAN, MUNICIPAL MAYOR, SAN PABLO, ZAMBOANGA DEL SUR TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF HEALTH – ZAMBOANGA PENINSULA CENTER FOR HEALTH DEVELOPMENT (DOH-ZP CHD) FOR THE PAYMENT OF SPECIAL RISK ALLOWANCE (SRA) & ACTUAL HAZARD PAY (AHP) BENEFITS FOR COVID-19 SERVICE DELIVERY PROVISION."**

**WHEREAS**, Administrative order no. 35, was issued by the office of the President, authorizing the grant of active hazard duty pay (AHDP) to human resources for health (HRHs) serving in the frontlines during the state of national emergency;

**WHEREAS**, Section 4(h) of Republic Act (RA) 11494 known as "Bayanihan to Recover as One Act", AO no. 36 was also issued by the President authorizing COVID-19 Special Risk Allowance (SRA) to private and public health workers directly catering to or in contact with COVID-19 patients during the state of national emergency;

**WHEREAS**, joint circular nos. 1 and 2 of the Department of Health (DOH) and the Department of Budget and Management (DBM) provide guidelines on the grant of AHDP and COVID-19 SRA to eligible health workers;

**WHEREAS**, under section 6.1.2 of the said joint circulars, the Department of Health-Zamboanga Peninsula Center for Health Development shall enter into a Memorandum of Agreement (MOA) for the transfer of funds for the AHDP and COVID-19 SRA to the LGU;

**WHEREFORE**, on motion by Hon. Allan S. Ceño, severally seconded, be it


**RESOLVED**, as it is hereby resolved, Authorizing Hon. Danilo A. Taucan, Municipal Mayor, San Pablo, Zamboanga Del Sur to enter into Memorandum of Agreement (MOA) with the Department of Health – Zamboanga Peninsula Center For Health Development (DOH-ZP CHD) for the payment of Special Risk Allowance (SRA) & Actual Hazard Pay (AHP) benefits for Covid-19 Service Delivery Provision.






