RESOLUTION NO. 2022-02

"A RESOLUTION AUTHORIZING THE HON. MUNICIPAL VICE MAYOR, ATTY. FLAVIO P. CORDERO, JR. AS THE OFFICIAL SIGNATORY OF THE LEGISLATIVE OFFICE IN THE GENERAL FUND ACCOUNT NO. 0522-1118-48 OF SAN PABLO, ZAMBOANGA DEL SUR IN ITS BANKING TRANSACTION AT LAND BANK OF THE PHILIPPINES (LBP) PAGADIAN BRANCH, PAGADIAN CITY".

WHEREAS, the Local Government Code of 1991, provides that the Municipal Vice Mayor shall exercise an executive and administrative powers in the legislative department being the regular presiding officer of the Sangguniang Bayan, sign all warrants drawn on the municipal treasury for all expenditures appropriated for the operation of the Sangguniang Bayan;

WHEREAS, in order not to hamper the delivery of basic services to the people of San Pablo, Zamboanga del Sur, it is in dire need that the signatory of the municipality's bank transaction be changed favorably to the newly elected authority.

WHEREAS, Atty. Flavio P. Cordero, Jr. had assumed his position as the duly elected Vice Mayor of San Pablo, Zamboanga del Sur on June 30, 2022, at 12:01 o'clock in the afternoon, at the office of the Vice Mayor, Municipal Compound, San Pablo, Zamboanga del Sur.


WHEREFORE, on motion by Hon. Jorge R. Gonzales, duly seconded by Hon. Carlomagno A. Jambo, be it
