## **RESOLUTION NO. 2022-04**

"A RESOLUTION AUTHORIZING THE HON. MUNICIPAL MAYOR,
DANILO A. TAUCAN, REPRESENTING THE LOCAL GOVERNMENT UNIT
OF SAN PABLO, ZAMBOANGA DEL SUR, TO ENTER INTO
MEMORANDUM OF AGREEMENT (MOA) IN BEHALD OF THE LOCAL
GOVERNMENT OF SAN PABLO, WITH THE DEPARTMENT OF
ENVIRONMENT AND NATURAL RESOURCES, ENVIRONMENTAL
MANAGEMENT BUREAU (DENR-EMB) FOR THE SUPPORT DELIVERY,
INSTATLLATION, TESTING AND COMMISSIONING OF SOLID WASTE
SHREDDER AND COMPOSTER."

**WHEREAS**, the municipality of San Pablo, Zamboanga del Sur, is a recipient of one (1) unit of biodegradable waste shredder with a minimum capacity of 250 kilograms, powered by 12 HP diesel engine with electric and manual start, composed of shredding chamber; shredder blades; and one (1) unit of composted with a capacity of 1,000 kilograms per batch for every 24 hours operation powered by five (5) HP by Electric Motor, 220v, 60hz, single phase with speed reducer 1:10 type 120;

**WHEREAS**, one of the responsibilities of the LGU of San Pablo is to provide a suitable site for the installation of the said equipment with a minimum area of 100 square meters, with a shed measuring at least 10 meters in length x 10 meters in width x 4 meters in height and a singl-phased power supply; Article III, Section 4 (a) of the Memorandum of Agreement

**WHEREFORE**, on motion by Hon. Carlomagno A. Jambo, duly seconded by Hon. Andres M. Villanueva, III, be it

**RESOLVED**, as it is hereby resolved, Authorizing The Hon. Municipal Mayor, Danilo A. Taucan, Representing The Local Government Unit Of San Pablo, Zamboanga Del Sur, To Enter Into Memorandum Of Agreement (MOA)

in Behalf of the Local Government of San Pablo, with The Department of Environment and Natural Resources, Environmental Management Bureau (DENR-EMB) for the Support Delivery, Installation, Commissioning of Solid Waste Shredder and Composter."
