RESOLUTION NO. 2022-09

"A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. DANILO A. TAUCAN TO ENTER INTO MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE STATISTIC AUTHORITY (PSA) FOR THE IMPLEMENTATION OF PHILSYS BIRTH REGISTRATION ASSISTANCE PROJECT IN THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR."

WHEREAS, a statistical survey is a method of collecting information about the population in which direct contact is made with the units of study through systematic means such as statistical survey forms, questionnaires or interview schedules;

WHEREAS, Art 49 of Implementing Rules and Regulations of Republic Act No. 10625, otherwise known as the Philippines Statistical Act of 2013, mandates the PSA to establish a Statistical Survey Review and Clearance System (SSRCS) to provide assistance and support to the statistical work of other government agencies in the PSS, including the LGU and the GOCCs;

WHEREAS, the specific objectives of the SSRC are to ensure sound design for data collection; minimize the burden placed upon respondents; effect economy in statistical data collection efforts; eliminate unnecessary duplication of statistical data collected; and achieve better coordination of government statistical activities;

WHEREAS, the proposed project entitled "PhilSys Birth Registration Assistance Project for the municipality of San Pablo" aims to increase civil registration in marginalized communities, particularly those belonging to the Indigenous Peoples (IP), Muslim Filipinos, and the poorest sector.

WHEREFORE, on motion by Hon. Andres M. Villanueva, III, duly seconded by Hon. Jezreel G. Abelidas, be it

RESOLVED, as it is hereby resolved, **AUTHORIZING THE MUNICIPAL MAYOR, HON. DANILO A.
