CALALAGAN MEMORIAL ELEMENTARY SCHOOL, IN COMPLIANCE WITH THE TERMS AND CONDITIONS AS STATED IN THE EXTRAJUDICIAL SETTLEMENT OF REAL ESTATE WITH DEED OF DONATION OF PORTION, EXECUTED BY THE HEIRS SPOUSES NOLON CALALAGAN AND ZUBLA T. CALALAGAN AS DONOR, AND THE DEPARTMENT OF EDUCATION AS DONEE, DATED DECEMBER 3, 2020, NOTARIZED BY ATTY. GLENN ERIC L. PERALTA."**
