RESOLUTION NO. 2022-38

"A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. DANILO A. TAUCAN TO ENTER INTO MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE STATISTIC AUTHORITY (PSA) AND THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG) FOR THE CONDUCT OF COMMUNITY-BASED MONITORING SYSTEM (CBMS) IN THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR."

WHEREAS, the Municipal Planning and Development Coordinator (MPDC) in his letter dated October 11, 2022, had requested this August body to pass a resolution to approve the conduct of Community-Based Monitoring System (CBMS) in the Municipality of San Pablo, Zamboanga del Sur to establish baseline data that will determine Government's course of action to address poverty in the municipality;

WHEREAS, Community-Based Monitoring System (CBMS) is a tool developed to provide policy makers a systematic gathering of data intended for improved governance and greater transparency and accountability in resource allocation that will track impacts of various economic reforms and policy.

WHEREFORE, on motion by Hon. Andres M. Villanueva, III, severally seconded, be it
