EXCERPT FROM THE MINUTES OF THE 12TH REGULAR SESSION OF THE 11TH MUNICIPAL COUNCIL, HELD AT THE MULTI-PURPOSE BUILDING, SAN PABLO, ZAMBOANGA DEL SUR ON OCTOBER 5, 2022.

RESOLUTION NO. 2022-39

"A RESOLUTION AUTHORIZING THE HON. MUNICIPAL MAYOR, DANILO A. TAUCAN OF SAN PABLO, ZAMBOANGA DEL SUR, TO ENTER INTO MEMORANDUM OF UNDERSTANDING (MOU) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FIELD OFFICE IX, REPRESENTED BY ITS REGIONAL DIRECTOR, FOR THE IMPLEMENTATION OF SUPPLEMENTAL FEEDING PROGRAM."

WHEREAS, Republic Act No. 11037 directed the DSWD, in coordination with the LGU's concerned, to implement supplemental feeding who's field office shall be responsible to manage and coordinate/supervise the regional/municipal implementation of the Program;

WHEREAS, one of the responsibilities of the LGU is to assist the DSWD in the monitoring and if necessary, provide augmentation support, in cash or in kind, in the implementation of the Program;

WHEREAS, the agreement shall be implemented in accordance with the terms and conditions stipulated in the Memorandum of Understanding and in accordance with the provision of Memorandum Circular 03, series of 2019 (Revised Procedures on the implementation of the Supplementary Feeding Program based on Amended Administrative Order no. 04, series of 2016).

WHEREFORE, on motion by Hon. Jane Leisley L. Arellano, severally seconded, be it

RESOLVED, as it is hereby resolved, authorizing Hon. Municipal Mayor Danilo A. Taucan of San Pablo. Zamboanga del Sur to enter into Memorandum of Understanding (MOU) with the DSWD for the implementation of Supplemental Feeding Program.


