**RESOLUTION NO. 2022-49**

**"A RESOLUTION APPROVING AND GRANTING THE ACCREDITATION OF THE CIVIL SOCIETY ORGANIZATIONS IN THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR."**

**WHEREAS**, Section 34 of the Local Government Code of 1991 states that the Local Government Units shall promote the establishment and operation of People's and Non-Governmental Organizations to become active partners in the pursuit of local autonomy;

**WHEREAS**, on July 14, 2022, the Department of the Interior and Local Government issued Memorandum Circular No. 2022-083, on the Guidelines on the Accreditation of Civil Society Organizations and Selection of Representative to the Local Special Bodies;

**WHEREAS**, the Following Organizations, through its Presidents, had signified its intention to be accredited CSO in the municipality of San Pablo to pursue active partnership with the Local Government Unit in the pursuit of local autonomy and nation building, to wit:

**WHEREAS**, said organizations had satisfactorily complied with the requirements and criteria for accreditation as civil society organizations in accordance with the procedures and guidelines set forth in DILG MC 2022-083.

**WHEREFORE**, on motion of Hon. Jorge R. Gonzales, severally seconded, be it

**RESOLVED, AS IT IS HEREBY RESOLVED**, to approve and grant, as it is hereby approved and granted, the respective accreditation of the above-mentioned organizations in the municipality of San Pablo, Zamboanga del Sur.

**RESOLVED FURTHER**, that this accreditation is effective only until **June 30, 2025**.

**RESOLVED FURTHERMORE**, that copies of this resolution be furnished to the Hon. Municipal Mayor, Danilo A. Taucan, the President of the above-mentioned organization, and the DILG Officer, San Pablo, Zamboanga del Sur, for their information and guidance.
