**EXCERPT FROM THE MINUTES OF THE 26<sup>th</sup> REGULAR SESSION OF THE 11<sup>TH</sup> MUNICIPAL COUNCIL, HELD AT THE MULTI-PURPOSE BUILDING, SAN PABLO, ZAMBOANGA DEL SUR ON FEBRUARY 22, 2023.**

**RESOLUTION NO. 2023-10**

**RESPECTFULLY REQUESTING THE PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES, HIS EXCELLENCY FERDINAND R. MARCOS, JR., THROUGH UNDERSECRETARY RAYMUND B. FERRER, ADMINISTRATOR OF THE OFFICE OF THE CIVIL DEFENSE (OCD) AND EXECUTIVE DIRECTOR OF THE NATIONAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL TO ALLOCATE FUNDING ASSISTANCE FOR THE CONSTRUCTION OF THE FLOOD CONTROL SYSTEM PROJECT AT BARANGAY POBLACION, SAN PABLO, ZAMBOANGA DEL SUR, AMOUNTING TO ONE HUNDRED FIFTY MILLION PESOS (P150,000,000.00) FROM THE AVAILABLE FUND OF THE NATIONAL DISASTER RISK REDUCTION MANAGEMENT (NDRRM).**

**WHEREAS**, Section 17 (b) (2) (viii) of the Local Government Code of 1991, states that the LGU shall provide services and facilities including, but are not limited to infrastructure facilities intended primarily to service the needs of the residents of the municipality and which are funded out of municipal funds including, but not limited to, municipal roads and bridges, school building and other facilities for elementary and secondary schools: clinics, Health Centers and other health facilities necessary to carry our health services: communal irrigation, small water impounding projects and other similar projects: fish ports: artesian wheels, spring development, rain water collectors and water supply system: sea wall, dikes, drainage and sewerage, and flood control: traffic signals and roads signs: and similar facilities, as part of the basic services developed to the municipalities;

**WHEREAS**, the municipality of San Pablo, is a 4<sup>th</sup> class municipality in the province of Zamboanga del Sur, which is politically subdivided into 28 barangays with an estimated population of 25,000;

**WHEREAS**, flooding, siltation, and erosion have been perennial problems in this municipality that continuously post a danger to the lives and properties of the inhabitants, and its massive destruction from this detrimental effect shall be swiftly and effectively addressed;

**WHEREAS**, the construction of the flood control system project will boost not only the safety and resiliency of the surrounding communities but also to disaster preparedness and mitigation;

**WHEREAS**, considering the limited resources of the LGU, this August Body deemed it necessary to source out funds, hence to appeal to the President of the Republic of the Philippines, His Excellency Ferdinand R. Marcos, Jr. through undersecretary Raymund B. Ferrer, Administrator of the office of the OCD and Executive Director of the National Disaster Risk Reduction and Management Council, for financial assistance;

**WHEREAS**, after careful review and exhaustive deliberation, and after finding the same to be proper and order:

**NOW THEREFORE**, premises above-considered, on motion by Hon. Jared P. Castillo, duly seconded by Hon. Raul R. Calunod, the Body

**RESOLVED**, as it hereby resolves, requesting the President of the Republic of the Philippines, His Excellency, Ferdinand R. Marcos Jr., through Undersecretary Raymund B. Ferrer, Administrator of the office of the OCD and Executive Director of the National Disaster Risk Reduction and Management Council, to allocate funding Assistance for the construction of the Flood Control project at Barangay Poblacion, San Pablo, Zamboanga del Sur, amounting One Hundred Fifty Million Pesos (P150,000,000.00) from the available fund of National Disaster Risk Reduction Management (NDRRM).
