RESOLUTION NO. 2023-102

"A RESOLUTION CREATING THE COMMITTEE ON COOPERATIVES AND NON-GOVERNMENT/PEOPLE'S ORGANIZATIONS (NGO/PO) IN THE OFFICE OF THE SANGGUNIANG BAYAN, SAN PABLO, ZAMBOANGA DEL SUR, MODIFYING FOR THE SAID PURPOSE THE INTERNAL RULES OF PROCEDURE OF THE SANGGUNIANG BAYAN, SAN PABLO, ZAMBOANGA DEL SUR."

WHEREAS, under Republic Act No. 9520, or the cooperative Code of 2008 provides that it is the declared policy of the State to foster the creation and growth of cooperatives as a practice vehicle for promoting self-reliance and harnessing people power towards the attainment of economic development and social justice;

3. Development of micro business enterprise;
4. All matters affecting the cooperatives development program of the government.
