RESOLUTION NO. 2023-106

"A RESOLUTION URGENTLY REQUESTING THE PROVINCIAL GOVERNOR, VICTOR J. YU, THROUGH THE PROVINCIAL ENGINEERING OFFICE, PROVINCE OF ZAMBOANGA DEL SUR TO ALLOW THE BARANGAY LOCAL GOVERNMENT UNIT OF POBLACION, SAN PABLO, ZAMBOANGA DEL SUR TO USE AND UTILIZE THE BACKHOE OF THE PROVINCE TO CONDUCT DREDGING ON THE RIVER SITUATED AT PUROK MANGGA, TANDUBUAY, SAN PABLO, ZAMBOANGA DEL SUR IN ORDER TO PREVENT OR AVOID FLOODING."

WHEREAS, during the rainy season, the residents of Purok Mangga, Tandubuy, San Pablo, Zamboanga del Sur had experienced and encountered problems in their respective places of residence due to flooding;

WHEREAS, this August Body had identified that the cause of flooding and it was due to the shallow situation of the river;

WHEREAS, there is a need urgently to conduct dredging on the said river to avoid future flooding;

WHEREFORE, on motion of Hon. Jonathan B. Medico, severally seconded, be it

RESOLVED, AS IT IS HEREBY RESOLVED, URGENTLY REQUESTING THE PROVINCIAL GOVERNOR, VICTOR J.
