RESOLUTION NO. 2023-118

WHEREAS, the Municipal Development Council (MDC) during their meeting, approved the Annual Investment Plan (AIP) for CY 2024 with a total appropriations of **Twenty Nine Million Six Hundred Twenty Two Thousand Two Hundred Ten Pesos and Twenty Centavos (P29,622.210.20)**;


