## **RESOLUTION NO. 2023-15**

"A RESOLUTION INQUIRING THE DISTRICT ENGINEER, DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS, SECOND ENGINEERING DISTRICT, GUIPOS, ZAMBOANGA DEL SUR ON THE STATUS OF THE CONCRETING ROAD PROJECT OF M.L. QUEZON AVENUE, BARANGAY POBLACION, SAN PABLO, ZAMBOANGA DEL SUR."

**WHEREAS**, it was observed that M.L. Quezon Avenue of Barangay Poblacion, San Pablo, Zamboanga del Sur was already concreted;;

**WHEREAS**, it was further observed that there was no proper turnover of the said project, not to mention the fact that there appears to be more works to be done but was left behind by the contractor;

**WHEREAS**, the canals of the said project was not properly done which caused traffic hazards not only to pedestrian but also to motorist;

**WHEREAS**, there is a need to inquire from the District Engineer of the DPWH, Guipos, Zamboanga del Sur on the status of the said project, whether it was already finished or not yet finished.

WHEREFORE, on motion of Hon. Jared P. Castillo, severally seconded, be it

**RESOLVED, AS IT IS HEREBY RESOLVED**, inquiring the District Engineer, Department of Public Works and Highways, Second Engineering District, Guipos, Zamboanga del Sur on the status of the concreting Road Project of M.L. Quezon Avenue, Barangay Poblacion, San Pablo, Zamboanga del Sur.

**RESOLVED FURTHER,** to request, as it is hereby requested, the District Engineer to furnish copy of the Program of Works of the said concreting project for this August Body's information and guidance.

Let copies of this resolution be furnished to the Regional Director, DPWH, Tetuan, Zamboanga City and the Secretary of DPWH, Room 201, DPWH Building, Bonifacio Drive, Port Area, Manila for their information and appropriate action.
