## **RESOLUTION NO. 2023-16**

"A RESOLUTION URGENTLY REQUESTING THE DISTRICT ENGINEER,
DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS, SECOND ENGINEERING
DISTRICT, GUIPOS, ZAMBOANGA DEL SUR TO IMMEDIATELY REPAIR OR
REHABILITATE THE DAMAGED PORTION OF THE NATIONAL ROAD,
SITUATED AT SITIO MANGAY, MIASIN, SAN PABLO, ZAMBOANGA DEL
SUR."

**WHEREAS**, portion of the National Road situated at Mangay, Miasin, San Pablo, Zamboanga del Sur was damaged and needs immediate repair or rehabilitation since it is very dangerous to motorists, cyclists and other commuters;

**WHEREAS**, it was observed that many individuals are having their sports activities like cycling and even viewing deck in Mangay, Lambayongan and the neighboring area passing through the National Road due to its beautiful scenic view of the seas and mountains;

**WHEREAS**, the condition of the said road poses a threat to the life and limb of those people who may pass by thereof, hence, there is an urgent need to have it repaired immediately.

WHEREFORE, on motion of Hon. Jared P. Castillo, severally seconded, be it
