## **RESOLUTION NO. 2023-18**

"A RESOLUTION URGENTLY REQUESTING THE PROVINCIAL ENGINEERING OFFICE, PROVINCIAL GOVERNMENT COMPLEX, DAO, PAGADIAN CITY TO APPRISE OR PROVIDE INFORMATION TO THIS AUGUST BODY AS TO THE TRUTH THAT THE CONSTRUCTION OF BARANGAY PUBLIC MARKET OF KAPAMANOK, SAN PABLO, ZAMBOANGA DEL SUR DOES NOT INCLUDE OR PROVIDE ANY FUNDING FOR THE FILLING-UP OF QUARRY MATERIALS NEITHER ROLL UP NOR PAINTING."

**WHEREAS**, according to some speculations, Program of Works for the construction of Barangay Public Market located at Barangay Kapamanok, San Pablo, Zamboanga del Sur, does not provide any funding for the filling up of the quarry materials, neither the rolled-up or paintings;

**WHEREAS**, per observation by this August Body, the above-mentioned project is already finished and soon to be turned over to the Barangay for occupancy by the tenants/stall owner.

WHEREFORE, on motion of Hon. Artemio C. Dayondon, severally seconded, be it

RESOLVED, AS IT IS HEREBY RESOLVED, URGENTLY REQUESTING THE PROVINCIAL ENGINEERING OFFICE, PROVINCIAL GOVERNMENT COMPLEX, DAO, PAGADIAN CITY TO APPRISE OR PROVIDE INFORMATION TO THIS AUGUST BODY AS TO THE TRUTH THAT THE CONSTRUCTION OF BARANGAY PUBLIC MARKET OF KAPAMANOK, SAN PABLO, ZAMBOANGA DEL SUR DOES NOT INCLUDE OR PROVIDE ANY FUNDING FOR THE FILLING-UP OF QUARRY MATERIALS NEITHER ROLL UP NOR PAINTING.
