EXCERPT FROM THE MINUTES OF THE 20TH REGULAR SESSION OF THE 11TH MUNICIPAL COUNCIL, HELD AT THE MULTI-PURPOSE BUILDING, SAN PABLO, ZAMBOANGA DEL SUR ON JANUARY 4, 2023.

RESOLUTION NO. 2023-19

"A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. DANILO A. TAUCAN TO EXECUTE A DEED OF DONATION ON A PORTION OF LOT NO. 180, CONTAINING AN AREA OF FOUR HUNDRED SQUARE METERS (400 SQ.M.), WHICH IS OWNED BY THE MUNICIPAL LOCAL GOVERNMENT UNIT OF SAN PABLO, IN FAVOR OF THE BARANGAY LOCAL GOVERNMENT UNIT OF POBLACION, SAN PABLO, HEADED BY ITS BARANGAY CAPTAIN, DENNIS P. CORDERO, WHICH SHALL BE USED AS A SITE FOR THE CONSTRUCTION OF A BARANGAY HALL."

WHEREAS, this August Body was informed by Barangay Captain Cordero that the Provincial Government through Governor Victor J. Yu has identified barangay Poblacion as a recipient for the construction of one (1) unit barangay hall building;

WHEREAS, through the representation and intervention of the Presiding Officer of this August Body, who informed Hon. Taucan that the barangay is in need of a site where the said barangay hall is to be constructed, the latter agreed to donate a portion of the Municipal Lot for the said purpose;

WHEREAS, this August Body after thorough discussion, had agreed to authorize Hon. Taucan to donate a portion of lot No. 180, containing an area of Four Hundred Square Meters (400 sq. m.) in favor of barangay Poblacion for the purpose as above-stated;

WHEREFORE, on motion by Hon. Jorge R. Gonzales, duly seconded by Hon. Andres M. Villanueva, III, be it

Resolved, as it is hereby resolved, authorizing the Municipal Mayor, Hon. Danilo A. Taucan to execute a Deed of Donation on a portion of Lot No. 180, containing an area of Four Hundred square meters (400 sq. m.), which is owned by the Municipal Local Government Unit of San Pablo, in favor of the Barangay Local Government Unit of Poblacion, San Pablo, headed by its Barangay Captain, Dennis P. Cordero, which shall be used as a site for the construction of a barangay hall.
