RESOLUTION NO. 2023-27

"A RESOLUTION REQUESTING THE HON. PROVINCIAL GOVERNOR VICTOR J. YU OF THE PROVINCE OF ZAMBOANGA DEL SUR, FOR THE IMMEDIATE REPAIR AND/OR REHABILITATION OF THE PROVINCIAL ROAD FROM BARANGAY SENIOR TO SACBULAN TO TUBO-PAIT AND SACBULAN TO BAG-ONG MISAMIS, ALL OF SAN PABLO, ZAMBOANGA DEL SUR."

WHEREAS, the Hon. Vice Mayor, Flavio P. Cordero, Jr. sent a letter dated April 12, 2023, addressed to the Hon. Members of the Sangguniang Bayan, this municipality, requesting for the passage of a resolution to request the Provincial Governor for the immediate repair and/or rehabilitation of the Provincial Road located in Barangay Senior to Sacbulan to Tubo-pait and barangay Sacbulan to Bag-ong Misamis, all of San Pablo, Zamboanga del Sur;

WHEREAS, the office of the Vice Mayor had received a several request, oral and thru verbal and social media post, from the concerned citizens of the said barangays complaining the bad condition of the said road and for immediate repair and/or rehabilitation;

WHEREAS, this August Body finds the said request and complain to be true and correct, as the Members of this Body can personally attest themselves the bad condition of the said road.
