EXCERPT FROM THE MINUTES OF THE 35TH REGULAR SESSION OF THE 11TH MUNICIPAL COUNCIL, HELD AT THE MULTI-PURPOSE BUILDING, SAN PABLO, ZAMBOANGA DEL SUR ON MAY 24, 2023.

RESOLUTION NO. 2023-44

"A RESOLUTION REQUESTING THE ADMINISTRATOR AND/OR ANY CONCERNED SCHOOL AUTHORITIES OF J.H. CERILLES STATE COLLEGE TO RESTORE AND/OR REOPEN BACK THE BACHELOR OF ELEMENTARY EDUCATION PROGRAM IN THE SCHOOL CAMPUS EXTENSION OF J.H. CERILLES STATE COLLEGE IN BARANGAY POBLACION, SAN PABLO, ZAMBOANGA DEL SUR."

WHEREAS, this August Body had received a letter from Vice Mayor Flavio P. Cordero, Jr. requesting for the enactment of a resolution requesting the administrator and/or any concerned school authorities of J.H. Cerilles State College to restore and/or reopen back the Bachelor of Elementary Education program in the school campus extension of J.H. Cerilles State College in Barangay Poblacion, San Pablo, Zamboanga del Sur;

WHEREAS, during the deliberation on the said matter it was gathered that during the previous years, JHCSC had offered a program for the course of Bachelor of Elementary Education, and as a matter of fact, the said school had already produced several graduates who eventually passed the License Examination for Public Teachers;

WHEREAS, it was further gathered that mostly, if not all, of the students who enrolled and graduated in the said school belong to below poverty line;

WHEREAS, the restoration and/or reopening back of the BEED Course will be beneficial and helpful to the poor and destitute students who are deserving but could not afford financially if they will enroll outside the Municipality of San Pablo;

WHEREAS, this August Body finds the request of Vice Mayor Cordero to be impressed with merit that would ultimately redound to the benefit of the deserving students who are poor and destitute, hence, the passage of this resolution is inevitable;
