EXCERPT FROM THE MINUTES OF THE 35TH REGULAR SESSION OF THE 11TH MUNICIPAL COUNCIL, HELD AT THE MULTI-PURPOSE BUILDING, SAN PABLO, ZAMBOANGA DEL SUR ON MAY 24, 2023.

RESOLUTION NO. 2023-47

"A RESOLUTION URGENTLY REQUESTING THE DISTRICT ENGINEER, SECOND ENGINEERING DISTRICT, GUIPOS, SAN PABLO, ZAMBOANGA DEL SUR TO DIRECT AND ORDER THE CONTRACTOR OF THE CANAL PROJECT, SITUATED AT ML QUEZON AVENUE, POBLACION, SAN PABLO, ZAMBOANGA DEL SUR TO SPEED-UP AND FAST-TRACK ITS CONSTRUCTION OF THE SAID PROJECT."

WHEREAS, this August Body had received a letter from Vice Mayor Flavio P. Cordero, Jr. requesting for the enactment of a resolution urgently requesting the District Engineer, Second Engineering District, Guipos, San Pablo, Zamboanga del Sur to direct and order the contractor of the canal project, situated at ML Quezon Avenue, Poblacion, San Pablo, Zamboanga del Sur to speed-up and fast-track its construction of the said project;

WHEREAS, during the deliberation on the said matter, it was gathered that previously it was not worked-on by the contractor, hence, this August Body had passed a resolution requesting the afore-named office to direct the contractor to construct the said canal project as soon as possible;

WHEREAS, it was also gathered that after the enactment of the said resolution the afore-named office had favorably acted on the said request and as a result thereof, the contractor had started to work-on on the said project;

WHEREAS, it was likewise gathered that the contractor had only worked-on the said project for a period of two (2) weeks only and thereafter the said project was left behind with a little percentage of works being done, while the unfinished works constitute NINETY-FIVE PERCENT (95%) that were left behind, without any construction workers who are working on the said project;

WHEREAS, this August Body finds the request of Vice Mayor Cordero to be impressed with merit that indeed the actuation of the contractor is not only detrimental and hazardous to the pedestrians and moving vehicles, but also disadvantageous to the government who paid the contractor out from the tax payers money, hence, this resolution;

WHEREFORE, on motion by Hon. Carlomagno A. Jambo, severally seconded,
be it

RESOLVED, as it is hereby resolved, **URGENTLY REQUESTING THE DISTRICT ENGINEER, SECOND ENGINEERING DISTRICT, GUIPOS, SAN PABLO, ZAMBOANGA DEL SUR TO DIRECT AND ORDER THE CONTRACTOR OF THE CANAL PROJECT, SITUATED AT ML QUEZON AVENUE, POBLACION, SAN PABLO, ZAMBOANGA DEL SUR TO SPEED-UP AND FAST-TRACK ITS CONSTRUCTION OF THE SAID PROJECT.**

RESOLVED FURTHER, let copies of the photographs showing the extent of the works doe by the contractor as of this time.

Let copies of this resolution be furnished to the Regional Director, DPWH, Regional Office IX; the Resident Auditor, DPWH; the Regional Director, COA, Regional Office; and other concerned agencies for information and appropriate action.
