**RESOLUTION NO. 2023-49**

**"A RESOLUTION REQUESTING THE PROVINCIAL GOVERNOR, HON. VICTOR J. YU, THROUGH PSWD TO ALLOCATE FUNDS INTENDED FOR FINANCIAL ASSISTANCE TO TWENTY ONE (21) INDIGENT RESIDENTS WHO WERE VICTIMS OF RIDO INCIDENTS IN THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR."**

**WHEREAS**, request letter from the Hon. Vice Mayor, Atty. Flavio P. Cordero, Jr., dated June 20, 2023 was submitted to this office requesting this agency to enact a resolution requesting Provincial Governor Hon. Victor J. Yu through PSWD to allocate funds intended for financial assistance to Twenty One (21) indigent residents who were victims of RIDO incidents of the municipality of San Pablo, Zamboanga del Sur;

**WHEREAS**, the aforementioned Twenty One (21) victims are in dire need for financial assistance, thus, there is a compelling reason to request financial allocation from Hon. Governor Victor J. Yu, as the Province of Zamboanga del Sur has sufficient funds for the said purpose;

**WHEREAS**, after thorough deliberation and review made by the members of the Sanggunian, the documents were found to be complete and sufficient.

**WHEREFORE**, on motion by Hon. Esmael M. Abellanos, severally seconded, be it
