## **RESOLUTION NO. 2023-51**

"A RESOLUTION REQUESTING THE SECRETARY, DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) SECRETARY, AMENAH F. PANGANDAMAN TO ALLOCATE FUNDS AMOUNTING SEVENTY MILLION PESOS (P70,000,000.00) FOR THE CONSTRUCTION OF PHASE-II FLOOD CONTROL WITH GROUTED RIPRAP RESTING ON CONCRETE WITH STEEL SHEET PILE FOUNDATION AT POBLACION, SAN PABLO, ZAMBOANGA DEL SUR."

WHEREAS, Section 17 (b) (2) (viii) of the Local Government Code of 1991, states that the LGU shall provide services and facilities including, but are not limited to infrastructure facilities intended primarily to service the needs of the residents of the municipality and which are funded out of municipal funds including, but not limited to, municipal roads and bridges, school building and other facilities for elementary and secondary schools: clinics, Health Centers and other health facilities necessary to carry our health services: communal irrigation, small water impounding projects and other similar projects: fish ports: artesian wheels, spring development, rain water collectors and water supply system: sea wall, dikes, drainage and sewerage, and flood control: traffic signals and roads signs: and similar facilities, as part of the basic services developed to the municipalities;

**WHEREAS**, the municipality of San Pablo, is a 4<sup>th</sup> class municipality in the province of Zamboanga del Sur, which is politically subdivided into 28 barangays with an estimated population of 25,000;

**WHEREAS**, flooding, siltation, and erosion have been perennial problems in this municipality that continuously post a danger to the lives and properties of the inhabitants, and its massive destruction from this detrimental effect shall be swiftly and effectively addressed;

**WHEREAS**, the construction of the flood control system project will boost not only the safety and resiliency of the surrounding communities but also to disaster preparedness and mitigation;

**WHEREAS**, after careful review and exhaustive deliberation, and after finding the same to be proper and order:

**NOW THEREFORE**, premises above-considered, on motion by Hon. Carlomagno A. Jambo, severally seconded, the Body

RESOLVED, as it hereby resolves, REQUESTING THE SECRETARY, DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) SECRETARY, AMENAH F.
