RESOLUTION NO. 2023-56

"A RESOLUTION URGENTLY REQUESTING THE PROVINCIAL GOVERNOR, VICTOR J. YU, THROUGH THE PROVINCIAL ENGINEERING OFFICE, PROVINCE OF ZAMBOANGA DEL SUR TO ALLOW THE BARANGAY LOCAL GOVERNMENT UNIT OF POBLACION, SAN PABLO, ZAMBOANGA DEL SUR TO USE AND UTILIZE THE BACKHOE OF THE PROVINCE TO CONDUCT DREDGING ON THE RIVER SITUATED AT POBLACION, SAN PABLO, ZAMBOANGA DEL SUR IN ORDER TO PREVENT OR AVOID FLOODING."

WHEREAS, the residents of Poblacion, San Pablo, Zamboanga del Sur are encountering flooding because of the shallow condition of Malbog River, which is situated at Barangay Poblacion, San Pablo, Zamboanga del Sur;

WHEREAS, per verification of the concerned officials in this municipality, it was gathered that there is really a need to conduct dredging on the said Malbog River in order to prevent any further flooding;

WHEREAS, the Local Government Units of San Pablo and Barangay Poblacion do not have any sufficient heavy equipment to conduct the said dredging, while on the other hand, the Provincial Government of Zamboanga del Sur appears to have sufficient heavy equipment to perform the dredging;


WHEREFORE, on motion by Hon. Jorge R. Gonzales, severally seconded, be it
