"A RESOLUTION URGENTLY REQUESTING THE DISTRICT ENGINEER, 2ND ENGINEERING DISTRICT, DPWH, GUIPOS, ZAMBOANGA DEL SUR TO APPRISE THE SANGGUNIANG BAYAN AS TO THE STATUS OF THE ROAD CONCRETING PROJECT OF JUAN LUNA STREET, BARANGAY POBLACION, SAN PABLO, ZAMBOANGA DEL SUR AND TO FURNISH COPY OF THIS AUGUST BODY OF THE PROGRAM OF WORKS OF THE SAID PROJECT."
