**RESOLUTION NO. 2023-68**

**"A RESOLUTION APPROVING BARANGAY ORDINANCE NO. 60, SERIES OF 2023 OF BARANGAY VILLAKAPA, SAN PABLO, ZAMBOANGA DEL SUR, RE: AN ORDINANCE AUTHORIZING THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR TO ISSUE BARANGAY CLEARANCES AND COLLECT CORRESPONDING BARANGAY CLEARANCE FEE IN THE APPLICATION FOR ANY BUSINESS RELATED TRANSACTIONS SUBJECT TO THE REMITTANCE OF THE AFORESAID FEES TO THE BARANGAY AND THE CONDITIONS HEREUNDER."**

**WHEREAS**, this August Body received barangay ordinance no. 60, series of 2023 from barangay Villakapa, San Pablo, Zamboanga del Sur;

**WHEREAS**, the provision of this ordinance shall be applicable to all businesses and individuals engaged in business transactions within barangay Villakapa, San Pablo, Zamboanga del Sur wherein any individual or business entity applying for a business permit, license renewal, or any other business-related transaction in barangay Villakapa shall be required to secure a barangay clearance from the LGU to be issued upon payment of corresponding barangay clearance fee as stipulated in the schedule of fees duly approved by the Sangguniang Barangay;

**WHEREFORE**, on motion by Hon. Jorge R. Gonzales, duly seconded by Hon. Raul R. Calunod, be it

**RESOLVED**, as it is hereby resolved, **APPROVING BARANGAY ORDINANCE NO. 60, SERIES OF 2023 OF BARANGAY VILLAKAPA, SAN PABLO, ZAMBOANGA DEL SUR, RE: "AN ORDINANCE AUTHORIZING THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR TO ISSUE BARANGAY CLEARANCES AND COLLECT CORRESPONDING BARANGAY CLEARANCE FEE IN THE APPLICATION FOR ANY BUSINESS RELATED TRANSACTIONS SUBJECT TO THE REMITTANCE OF THE AFORESAID FEES TO THE BARANGAY AND THE CONDITIONS HEREUNDER."**

**RESOLVED FURTHER**, that the LGU, in coordination with the barangay authorities, shall enforce the imposition of penalties and sanctions, including the closure of businesses found to be in non-compliance with the said ordinance.
