RESOLUTION NO. 2023-83

"A RESOLUTION AUTHORIZING HON. DANILO A. TAUCAN AND/OR HON. FLAVIO P. CORDERO, JR., MUNICIPAL MAYOR AND VICE MAYOR, RESPECTIVELY, BOTH OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF SAN PABLO, ZAMBOANGA DEL SUR TO TRANSACT AND/OR NEGOTIATE THE HEIRS OF SARIP MACMOD, THE OWNER OF THE LAND, SITUATED AT POBLACION, SAN PABLO, ZAMBOANGA DEL SUR, WHICH PORTION THEREOF HAD LONG BEEN POSSESSED AND OCCUPIED BY THE RESIDENTS OF THE SAID BARANGAY AND WHO ALREADY CONSTRUCTED THEIR RESPECTIVE RESIDENTIAL HOUSES THEREAT, FOR ITS ACQUISITION IN FAVOR OF THE SAID POSSESSORS AND/OR OCCUPANTS AND FOR BARANGAY OR MUNICIPAL ROAD AND FOR OTHER LEGAL PURPOSE OR PURPOSES."

WHEREAS, the Office of the Vice Mayor had been requested by the residents of Barangay Poblacion, San Pablo, Zamboanga del Sur to help them regarding the residential land that they were occupying, which is part of the titled land of the heirs of Sarip Macmod as the owners thereof;

WHEREAS, it was gathered that the affected residents of the said residential land had already long been occupying and residing with their respective residential houses thereon since time immemorial;

WHEREAS, there is an imperative need for the municipal local officials to find any favorable actions or solutions as regards the said problem for the benefit of the said residents;

WHEREAS, the Local Government Code provides and authorizes the Municipal Local Government Unit to undertake housing programs to its constituencies or any programs that will benefit the general welfare of its residents;

WHEREFORE, on motion by Hon. Jean Leisly L. Arellano-Virtudazo, duly seconded by Hon. Esmael M. Abellanosa, be it
