**RESOLUTION NO. 2023-84**

**"RESOLUTION URGENTLY AND RESPECTFULLY REQUESTING THE REGIONAL DIRECTOR, DPWH, REGION IX, ZAMBOANGA CITY AND/OR THE DISTRICT ENGINEER, SECOND ENGINEERING DISTRICT, DPWH, GUIPOS, ZAMBOANGA DEL SUR TO START THE NEXT PHASE OF THE ROAD CONCRETING PROJECT WITH ITS PROJECT DESCRIPTION- "CONSTRUCTION/IMPROVEMENT OF ACCESS ROAD LEADING TO SEAPORTS (KALSADA TUNGO SA PALIPARAN, RILES AT DAUNGAN PROGRAM - KATUPARAN) ALONG REBOKON-PALARAN, TUBO PAIT-SACBULAN-SENIOR-SAGASAN ROAD LEADING TO SAN PABLO PORT, SAN PABLO, ZAMBOANGA DEL SUR", FROM TUBO-PAIT, DUMALINAO TO SACBULAN-SENIOR-SAGASAN, ALL OF SAN PABLO, ZAMBOANGA DEL SUR, INSTEAD FROM SENIOR TO SACBULAN TO TUBO-PAIT."**

**WHEREAS**, this August Body had observed that there is an on-going road concreting project in Barangay Sagasan to Barangay Senior, both of San Pablo, Zamboanga del Sur under its project description "CONSTRUCTION/IMPROVEMENT OF ACCESS ROAD LEADING TO SEAPORTS (KALSADA TUNGO SA PALIPARAN, RILES AT DAUNGAN PROGRAM - KATUPARAN) ALONG REBOKON-PALARAN, TUBO PAIT-SACBULAN-SENIOR-SAGASAN ROAD LEADING TO SAN PABLO PORT, SAN PABLO, ZAMBOANGA DEL SUR";

**WHEREAS**, it is the consensus of this August Body that if ever the next phase of the said road concreting project will be implemented, it is suggested that it will start instead from Barangay Tubo-pait, Dumalinao to Barangay Sacbulan-Senior, both of San Pablo, Zamboanga del Sur, because it is more beneficial to all the residents of the said barangay who will be transporting on the said road, not to mention the fact that the said road is presently difficult for the residents to transport because of its present bad condition;
