RESOLUTION NO. 2023-85

"A RESOLUTION URGENTLY AND RESPECTFULLY REQUESTING THE REGIONAL DIRECTOR, DPWH, REGION IX, ZAMBOANGA CITY AND/OR THE DISTRICT ENGINEER, SECOND ENGINEERING DISTRICT, DPWH, GUIPOS, ZAMBOANGA DEL SUR TO CONSTRUCT A "ROTONDA" ALONG THE COASTAL ROAD PROJECT AT THE JUNCTION OF THE PROVINCIAL ROAD, SITUATED AT POBLACION, SAN PABLO, ZAMBOANGA DEL SUR."

WHEREAS, it was gathered by this August Body that there is now an on-going road concreting project that will connect the coastal road from Poblacion to Barangay Tandubua, both of San Pablo, Zamboanga del Sur passing through the existing provincial road;

WHEREAS, this August Body is apprehensive that once the said project will be connected and finished, it will pass through across the existing provincial road and there is a great probability that traffic accidents may transpire among the motorist who will pass-by on the said road;

WHEREAS, in order to prevent or avert any traffic accidents or untoward incidents, this August Body feels that there is an imperative need to construct a Rotonda on the said junction or crossing so that the flow of traffic could be regulated thereby;

WHEREFORE, on motion by Hon. Artemio C. Dayondon, severally seconded, be it
