**RESOLUTION NO. 2023-99**

**"A RESOLUTION ADOPTING AND SUPPORTING THE POLICIES FOR MANDATORY BREASTFEEDING IN THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR, AS RECOMMENDED BY THE MUNICIPAL HEALTH OFFICE OF THIS MUNICIPALITY."**

**WHEREAS**, presented for consideration is the draft policies for mandatory breastfeeding in the municipality of San Pablo, Zamboanga del Sur as recommended by the Municipal Health Office, for review and approval by the Sangguniang Bayan of this Municipality;

**WHEREAS**, included in the policies mentioned is that all pregnant women including her family should be alarmed that no feeding bottles, artificial Teats and Milk substitute are allowed in the birthing facility, otherwise they will be confiscated, and all mothers discharged from the birthing facility should be referred to the Community Breastfeeding Support Group (CBFSG) in their barangay which is composed of the NDP's, RHMPs, CHT Navigators, BHWs, BNS Parents Leaders, Barangay Chairman and Hilots in every Barangay.

**WHEREFORE**, on motion of Hon. Andres M. Villanueva, III, severally seconded, be it

**RESOLVED, AS IT IS HEREBY RESOLVED, ADOPTING AND SUPPORTING THE POLICIES FOR MANDATORY BREASTFEEDING IN THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR, AS RECOMMENDED BY THE MUNICIPAL HEALTH OFFICE OF THIS MUNICIPALITY.**
