EXCERPT FROM THE MINUTES OF THE 62^{ND} REGULAR SESSION OF THE 11^{TH} MUNICIPAL COUNCIL, HELD AT THE MULTI-PURPOSE BUILDING, SAN PABLO, ZAMBOANGA DEL SUR ON JANUARY 17, 2024.

RESOLUTION NO. 2024-05

"A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. DANILO A. TAUCAN TO ENTER INTO MEMORANDUM OF AGREEMENT WITH THE SOCIAL SECURITY SYSTEM (SSS) FOR THE ENROLLMENT OF CONTRACT OF SERVICE (COS), JOB ORDER (JO) AND OTHER EMPLOYEES OF SAN PABLO, ZAMBOANGA DEL SUR."

WHEREAS, the municipality of San Pablo recognizes the importance of providing comprehensive social security coverage to all employees, including those under Contract of service (COS) and Job Order personnel positions;

WHEREAS, entering into a Memorandum of Agreement (MOA) with the Social Security System will facilitate the seamless and effective provision of social security benefits to COS and Job Order personnel employees;

WHEREAS, the proposed MOA outlines the terms and conditions for the implementation of social security coverage to COS and Job Order personnel employees.

WHEREFORE, on motion by Hon. Andres M. Villanueva, III, severally seconded, be it

RESOLVED, AS IT IS HEREBY RESOLVED, that:

- 1. The Municipal Mayor is hereby authorized to enter into a Memorandum of Agreement with the Social Security System (SSS) for the provision of social security benefits to COS and Job Order personnel employees.
- 2. The Municipal Mayor, together with relevant municipal officials, shall review and finalize the terms and conditions contained within the proposed MOA with the Social Security System.
- 3. The Municipal Mayor is further authorized to represent the Municipality of San Pablo, Zamboanga del Sur in all matters concerning the negotiation, execution, and implementation of the MOA with the Social Security System.
- 4. After conducting necessary consultations and ensuring compliance with all legal requirements, the Municipal Mayor is empowered to affix their signatures to the finalized MOA, thereby binding the Municipality of San Pablo and the Social Security System to the agreed-upon terms and conditions.
- 5. This resolution shall take effect immediately upon approval.
