## **RESOLUTION NO. 2024-09**

"A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON.
DANILO A. TAUCAN TO ENTER INTO MEMORANDUM OF AGREEMENT
(MOA) WITH THE DEPARTMENT OF HEALTH (DOH) IN CONNECTION
WITH THE IMPLEMENTATION OF ICLINICSYS IN THE MUNICIPALITY
OF SAN PABLO, ZAMBOANGA DEL SUR."

**WHEREAS**, the advancement of technology and digital solutions has greatly improved the efficiency and delivery of services in various sectors;

**WHEREAS**, the Department of Health (DOH) has developed **iClinicSys**, a comprehensive electronic health record system, aimed at enhancing the management and delivery of healthcare services;

**WHEREAS**, the implementation of **iClinicSys** in the Local Government Unit (LGU) will significantly improve healthcare access and quality for our constituents;

**WHEREAS**, the LGU recognizes the importance of leveraging technology to streamline healthcare processes, enhance data management, and promote efficient service delivery;

**WHEREFORE**, on motion by Hon. Jane Leisley L. Arellano-Virtudazo, severally seconded, be it

**RESOLVED**, as it is hereby resolved, authorizing the Municipal Mayor, Hon. Danilo A. Taucan to enter into Memorandum of Agreement (MOA) with the Department of Health (DOH) in connection with the implementation of **iClinicSys** in the municipality of San Pablo, Zamboanga del Sur.

**RESOLVED FURTHER,** that the terms and conditions of the MOA, including but not limited to the responsibilities, obligations, and rights of the LGU and the DOH, shall be subject to review and approval by the appropriate legal authorities.

**BE IT FURTHER RESOLVED**, that the Local Chief Executive, together with the designated representatives of the LGU, is hereby authorized to negotiate and finalize the terms of the MOA with the DOH ensuring the interests of the LGU and its constituents are upheld.
