RESOLUTION NO. 2024-12

"A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON.
DANILO A. TAUCAN TO ENTER INTO MEMORANDUM OF AGREEMENT
(MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND
DEVELOPMENT (DSWD) FOR SOCIAL PENSION PROGRAM OF SENIOR
CITIZENS."

WHEREAS, the Social Pension Program is designed to provide financial assistance to indigent Senior Citizens who are not covered by any contributory pension insurance;

WHEREAS, the Local Government Unit (LGU) recognizes the importance of ensuring the welfare and well-being of its senior citizens, particularly those living in poverty;

WHEREAS, the Department of Social Welfare and Development (DSWD) has established the Social Pension Program to address the needs of indigent senior citizens;

WHEREAS, the LGU believes that collaborating with the DSWD in the implementation of the Social Pension Program will significantly improve the living conditions and social protection of senior citizens in the locality.

WHEREFORE, on motion by Hon. Jane Leisley L. Arellano-Virtudazo, severally seconded, be it

RESOLVED, as it is hereby resolved, AUTHORIZING THE MUNICIPAL MAYOR, HON. DANILO A. TAUCAN TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FOR SOCIAL PENSION PROGRAM OF SENIOR CITIZENS.

BE IT FURTHER RESOLVED, that the Local Chief Executive, is empowered to provide the necessary support and resources for the successful implementation of the program.

BE IT RESOLVED FINALLY, that the LCE shall be responsible for ensuring compliance with the terms and conditions as stipulated in the MOA, and shall be authorized to sign all related documents, agreements, and contracts on behalf of the LGU.
