"A RESOLUTION ADOPTING RESOLUTION NO. 2024-2 OF MUNICIPAL DEVELOPMENT COUNCIL (MDC), RE: A RESOLUTION REALIGNING THE REMAINING FUNDS FROM COUNTERPART FUND FOR FOREIGN, NATIONAL, PROVINCIAL AND LOCAL FUNDED PROJECTS FOR LOAN REPAYMENT OF THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR, AMOUNTING ONE MILLION PESOS (P1,000,000.00)."
