EXCERPT FROM THE MINUTES OF THE 87TH REGULAR SESSION OF THE 11TH MUNICIPAL COUNCIL, HELD AT THE MULTI-PURPOSE BUILDING, SAN PABLO, ZAMBOANGA DEL SUR ON NOVEMBER 13, 2024.

RESOLUTION NO. 2024-139

"A RESOLUTION AUTHORIZING THE HON. MUNICIPAL MAYOR, DANILO A. TAUCAN TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE PROVINCIAL GOVERNMENT OF ZAMBOANGA DEL SUR FOR THE PURCHASE OF RESCUE VEHICLE (Utility Van – TRAVIZ) FOR OPERATION DURING EMERGENCY RESPONSE OF THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR."

WHEREAS, the municipality of San Pablo, Zamboanga del Sur is in dire need of Rescue Vehicle (Utility Van – TRAVIZ) for use during emergency response to carry patients from San Pablo to any referral hospital;

WHEREAS, the Provincial Government of Zamboanga del Sur will provide Fifty percent (50%) of the total price to be paid for the procurement of the said rescue vehicle (Utility Van – TRAVIZ) to be used for emergency response operation, disaster response and other similar activities aimed in disaster preparedness, mitigation and rehabilitation;

WHEREAS, the Municipal Officials of San Pablo, after reading the content in the Memorandum of Agreement, signified intention to avail of the offer of the Provincial Government to shoulder the Fifty percent (50%) of the total price; the procured vehicle shall be owned by the municipality of San Pablo, however, if the need arise, the Provincial Government may request to borrow the said equipment.

WHEREFORE, on motion of Hon. Andres M. Villanueva, III, severally seconded, be it

RESOLVED, as it is hereby resolved, **AUTHORIZING THE HON. MUNICIPAL MAYOR, DANILO A. TAUCAN TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE PROVINCIAL GOVERNMENT OF ZAMBOANGA DEL SUR FOR THE PURCHASE OF RESCUE VEHICLE (Utility Van – TRAVIZ) FOR OPERATION DURING EMERGENCY RESPONSE OF THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR.**
