RESOLUTION NO. 2024-154

"A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. DANILO A. TAUCAN TO SIGN INTO MEMORANDUM OF AGREEMENT WITH THE MARGOSATUBIG REGIONAL HOSPITAL (MRH) FOR ESTABLISHMENT OF SMOOTH REFERRAL SYSTEM FOR PATIENT WHO DEVELOP RISK FACTORS DURING THE COURSE OF THEIR PRESENT PREGNANCY, OR SHOULD THE PATIENT REQUIRE INTRAPARTUM REFERRAL FOR OBSTETRIC EMERGENCIES."

WHEREAS, patients from the San Pablo, ZDS Municipal Health Center, who develop risk factors during the course of the present pregnancy or that require intrapartum referral or obstetric emergencies are usually referred to other health facilities of higher capability like the Margosatubig Regional Hospital (MRH) for further management and/or delivery;

WHEREAS, Margosatubig Regional Hospital (MRH) is a referral facility with office address at Poblacion, Matgosatubig, Zamboanga del Sur, represented by the OIC-Medical Center Chief II, **DR. JOVER C. PUNSALAN, MD, FPOA, FPSS, MSHM**. It is equipped with medical instruments and equipment needed for the facility with adequate facilities and competent, trained staff capable of providing maternal and neonatal services, also the nearest Hospital from the municipality of San Pablo;

WHEREAS, High risk pregnant mothers or with pregnancy-related complications is better managed in higher level hospital.

WHEREFORE, on motion of Hon. Artemio C. Dayondon, severally seconded, be it

RESOLVED, as it is hereby resolved, **AUTHORIZING THE MUNICIPAL MAYOR, HON. DANILO A. TAUCAN TO SIGN INTO MEMORANDUM OF AGREEMENT WITH THE MARGOSATUBIG REGIONAL HOSPITAL (MRH) FOR ESTABLISHMENT OF SMOOTH REFERRAL SYSTEM FOR PATIENT WHO DEVELOP RISK FACTORS DURING THE COURSE OF THEIR PRESENT PREGNANCY, OR SHOULD THE PATIENT REQUIRE INTRAPARTUM REFERRAL FOR OBSTETRIC EMERGENCIES.**
