RESOLUTION NO. 2024-25

"A RESOLUTION AUTHORIZING, ALLOWING AND SUPPORTING THE ESTABLISHMENT OF COAST GUARD SUB-STATION, PHILIPPINE COAST GUARD OF SAN PABLO, ZAMBOANGA DEL SUR WHICH WILL BE SITUATED AND LOCATED AT THE OLD BARANGAY HALL, WHARF AREA, BARANGAY MARCOS VILLAGE, SAN PABLO, ZAMBOANGA DEL SUR."

WHEREAS, this August Body was informed that the Philippine Coast Guard would establish a Coast Guard Sub-station, to be located at the old Barangay Hall, wharf area, Barangay Marcos Village, San Pablo, Zamboanga del Sur, and the Barangay Officials had already approved a resolution authorizing and allowing to establish such sub-station as aforementioned;

WHEREAS, in order to strengthen the establishment of such sub-station, this Body feels to authorize, allow and support such endeavor, as there is really an imperative need for such sub-station because on eastern side of this municipality is comprises of the following barangays, namely: Culasian, Teniapan, Sagasan, Marcos Village, Tandubuay, Buton, Bubual and Ticala Island, which are all situated in the coastal area fronting Yllana Bay and the presence of the coast guard personnel would help the maintenance of peace and order in the coastal area.
