EXCERPT FROM THE MINUTES OF THE 73RD REGULAR SESSION OF THE 11TH MUNICIPAL COUNCIL, HELD AT THE MULTI-PURPOSE BUILDING, SAN PABLO, ZAMBOANGA DEL SUR ON APRIL 17, 2024.

RESOLUTION NO. 2024-34

"A RESOLUTION URGENTLY AND STRONGLY URGING THE ACTING CHIEF OF POLICE, PMAJ JAYCEL ROTA CABARRUBIAS, SAN PABLO MUNICIPAL POLICE STATION, PHILIPPINE NATIONAL POLICE, SAN PABLO, ZAMBOANGA DEL SUR, TO IMMEDIATELY STOP THE OPERATION OF A COCKPIT AND ITS COCKFIGHTING THEREAT, SITUATED AT BARANGAY TENIAPAN, SAN PABLO, ZAMBOANGA DEL SUR."

WHEREAS, during its regular session today, this August Body was in receipt of a copy of the DILG-IX Legal Advisory, dated April 08, 2024, signed by PAISAL O. ABUTAZIL, CESO III, Regional Director, DILG IX, RGC Balintawak, Pagadian City, the contents of which are self-explanatory;

WHEREAS, during its discussion and deliberations, this August Body had incidentally discovered that a certain cockpit was operating and conducting a cockfighting thereat, situated at Barangay Teniapan, San Pablo, Zamboanga del Sur, without franchise and business permit;

WHEREAS, it was also deliberated that there is an existing cockpit which was granted with a franchise, to a certain MR. WILLIAM R. LABAJO, situated at Barangay Kapamanok, San Pablo, Zamboanga del Sur, and under such circular the Municipality of San Pablo is only authorized to grant a franchise to one (1) cockpit only;

WHEREAS, there is an urgent need to stop the operation of the said cockpit in Barangay Teniapan, San Pablo, Zamboanga del Sur, which does not have any franchise neither business permit.

WHEREFORE, on motion by HON. JORGE R. GONZALES, severally seconded, be it


