**RESOLUTION NO. 2024-36**

**"A RESOLUTION COUNTERPARTING THE TOTAL AMOUNT OF ELEVEN MILLION FOUR HUNDRED SEVENTY-NINE THOUSAND NINE HUNDRED SIXTY-EIGHT PESOS AND TEN CENTAVOS (P11,479,968.10) FOR THE KALAH I CIDSS PHASE II PROJECT IMPLEMENTATION."**

**WHEREAS**, the municipality of San Pablo, Zamboanga del Sur is a recipient of KALAH I CIDSS Phase II Project, now ready for implementation after depositing the counterpart fund of Eleven Million Four Hundred Seventy-Nine Thousand Nine Hundred Sixty Eight Pesos and Ten Centavos (P11,479,968.10);

**WHEREAS**, there is an available appropriation for counterpart fund for foreign, national, and provincial funded projects in the 2024 Annual Investment Plan (AIP);

**WHEREAS**, the Local Officials also appropriated Six Million Pesos (P6,000,000.00) from the 2023 current surplus under appropriation ordinance no. 06-2024, non-office expenditure;

**WHEREAS**, the total amount of Five Million Four Hundred Seventy-Nine Thousand Nine Hundred Sixty-Eight Pesos and Ten Centavos (P5,479,968.10) shall be taken from the 2024 Annual Investment Plan, item no. 1.

**NOW, THEREFORE**, on motion of **Hon. Jane Leisly Arellano-Virtudazo**, severally seconded;

**RESOLVED, AS IT IS HEREBY RESOLVED COUNTERPARTING THE TOTAL AMOUNT OF ELEVEN MILLION FOUR HUNDRED SEVENTY-NINE THOUSAND NINE HUNDRED SIXTY-EIGHT PESOS AND TEN CENTAVOS (P11,479,968.10) FOR THE KALAH I CIDSS PHASE II PROJECT IMPLEMENTATION.**
