RESOLUTION NO. 2024-46

"A RESOLUTION AUTHORIZING THE MUNICIPAL VICE MAYOR, HON. ATTY. FLAVIO P. CORDERO, JR. TO ENTER INTO CONTRACT OF SERVICES FOR THE PURPOSE OF COVERING THE SALARY OF USTADZ HALID T. ALANG AS LOCALLY PAID ARABIC LANGUAGE AND ISLAMIC VALUES EDUCATION (ALIVE) TEACHER OF CULASIAN, THIS MUNICIPALITY, FROM JANUARY 3, 2024 TO MARCH 31, 2024, AMOUNTING EIGHTEEN THOUSAND PESOS (P18,000.00), CHARGEABLE TO ANY SALARY SAVINGS IN THE OFFICE OF THE SANGGUNIAN BAYAN, SAN PABLO, ZAMBOANGA DEL SUR."

WHEREAS, Ustadz Halid T. Alang of Barangay Bubual, San Pablo, Zamboanga del Sur personally explain his concern and seek the Council's help regarding the collection of his unpaid salary for the actual services he rendered from January 3 to March 31, 2024 for his employment as Locally Paid Arabic Language and Islamic Values Education (ALIVE) Teacher of Culasian Elementary School, Culasian, San Pablo, Zamboanga del Sur;

WHEREAS, his originally signed contract as Locally Paid ALIVE Teacher is from September 3, 2023 to December 31, 2023;

WHEREAS, he assumed that his contract will be extended because he was not advised neither informed that he would stop teaching, hence had rendered his services for the next Three (3) months without having signed a valid contract.
