EXCERPT FROM THE MINUTES OF THE 74TH REGULAR SESSION OF THE 11TH MUNICIPAL COUNCIL, HELD AT THE MULTI-PURPOSE BUILDING, SAN PABLO, ZAMBOANGA DEL SUR ON MAY 8, 2024.

RESOLUTION NO. 2024-49

"A RESOLUTION AUTHORIZING HON. DANILO A. TAUCAN, MUNICIPAL MAYOR, TO EXECUTE AND SIGN A DEED OF DONATION IN BEHALF OF THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR, AND IN FAVOR OF THE MUNICIPAL FIRE STATION, BUREAU OF FIRE PROTECTION, SAN PABLO, ZAMBOANGA DEL SUR, INVOLVING FROM A PORTION OF LAND OWNED BY THE MUNICIPALITY OF SAN PABLO, KNOWN AS LOT NO. 187-A-2, PSD-9-095478, DATED 22 APRIL 2024, CONSISTING WITH AN AREA OF FIVE HUNDRED (500) SQUARE METERS, WHICH MUST BE LOCATED ADJACENT AND CONTIGUOUS TO THE PRESENT FIRE STATION, KNOWN AS LOT 187-D."

WHEREAS, this August Body had received a letter from SFO4 Jupie D. Aburido, Officer-in-Charge, Municipal Fire Station, San Pablo, Zamboanga del Sur requesting the municipality to make an additional donation on a portion of land owned by the municipality to be used as an extension and/or expansion of the present municipal fire station, consisting of five hundred (500) square meters, to be located adjacent and contiguous to the present municipal fire station;

WHEREAS, after thorough deliberation and evaluation, this August Body is convinced that the request is meritorious and beneficial to the said office and the people of San Pablo, Zamboanga del Sur, hence, it deserves the body's favorable approval;

WHEREAS, this August Body agrees to authorize the municipal mayor, Hon. Danilo A. Taucan, to execute and sign a deed of donation in favor of the Municipal Fire Station, Bureau of Fire Protection, San Pablo, Zamboanga del Sur involving a portion of Lot No. 187-A-2, consisting of five hundred (500) square meters, the metes and bounds of which is subject to mutual agreement by and between the municipality and the municipal fire station during the actual subdivision survey for the segregation of the donated portion which must be adjacent and contiguous to the present fire station;

WHICH MUST BE LOCATED ADJACENT AND CONTIGUOUS TO THE PRESENT FIRE STATION, KNOWN AS LOT 187-D.
