RESOLUTION NO. 2024-56

"A RESOLUTION CHANGING THE PROJECT TITLE "CONSTRUCTION OF CANOPY AND FENCE TO ADDITIONAL COUNTERPART FUND FOR KALAHICIDSS PROJECT CLUSTERED EVACUATION CENTER AMOUNTING ONE MILLION FOUR HUNDRED SIXTY-EIGHT THOUSAND FOUR HUNDRED FIFTY-TWO PESOS (P1,468,452.00)."
