EXCERPT FROM THE MINUTES OF THE 77TH REGULAR SESSION OF THE 11TH MUNICIPAL COUNCIL, HELD AT THE MULTI-PURPOSE BUILDING, SAN PABLO, ZAMBOANGA DEL SUR ON JULY 17, 2024.

RESOLUTION NO. 2024-58

"A RESOLUTION EXPRESSLY SUPPORTING AND ADOPTING THE DENR'S PROGRAM FOR THE CONTINUATION OF THE EXISTING IDENTIFIED AREAS OF BARANGAY TANDUBUAY, BUTON, BUBUAL AND TICALA ISLAND, ALL OF THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR AS WILD LIFE SANCTUARY PROTECTED AREA PURSUANT TO RESIDENTIAL PROCLAMATION NO. 2152, DATED DECEMBER 29, 1981 BY THEN PRESIDENT FERDINAND E. MARCOS."

WHEREAS, during its 77TH regular session on 17 July 2024, Mrs. Rorie Ann Robles, Protected Area Focal Person, CENRO, DENR, Guipos, Zamboanga del Sur had personally appeared before this August Body and requested to pass a resolution to support and adopt the DENR's program in connection with the wild life sanctuary protected area, situated at Barangay Tandubuay, Buton, Bubual and Ticala Island, all of this municipality, pursuant to Proclamation No. 2152, dated 29 December 1981 by then President Ferdinand E. Marcos;

WHEREAS, after thorough discussions and deliberations, this August Body was convinced that the passage of such resolution would favorably redound and benefit not only to the present inhabitants of this municipality, but also to the future generations, not to mention the fact that it would create a balanced ecological environment;

WHEREAS, it was also gathered that, by continuing the DENR programs in relation to the wild life sanctuary protected areas in the four (4) barangays as abovementioned, would also increase the potential and presence of additional wildlife species which might migrate on those areas, and if properly handled and regulated it may boost additional wildlife species in the areas;

WHEREFORE, on motion by Hon. Andres M. Villanueva III, severally seconded, be it

RESOLVED, as it is hereby resolved, **EXPRESSLY SUPPORTING AND ADOPTING THE DENR'S PROGRAM FOR THE CONTINUATION OF THE EXISTING IDENTIFIED AREAS OF BARANGAY TANDUBUAY, BUTON, BUBUAL AND TICALA ISLAND, ALL OF THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR AS WILD LIFE SANCTUARY PROTECTED AREA PURSUANT TO RESIDENTIAL PROCLAMATION NO. 2152, DATED DECEMBER 29, 1981 BY THEN PRESIDENT FERDINAND E. MARCOS.**
