"A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. DANILO A. TAUCAN TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE TAGUM COOPERATIVE RELATIVE TO MEMBERSHIP AND SUBSCRIPTION AGREEMENT FOR LOANS OF INTERESTED OFFICIALS AND EMPLOYEES OF SAN PABLO, ZAMBOANGA DEL SUR."

WHEREAS, Tagum Cooperative with Pagadian Satellite office at GF Javaved Building, Palmera, Balangasan, Pagadian City is extending Salary Loan Facility to elective and appointive officials and employees of San Pablo, Zamboanga del Sur (whose term of office are permanent or co-terminus to the appointing authority) and who are members of the Tagum Cooperative;
